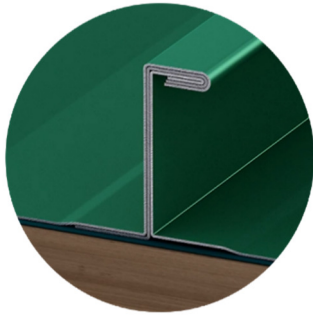

#### Panel Material (as tested):

24ga (min) steel. *Corrosion resistant per FBC 1507.4.3 where required.*

#### Panel Description:

Mechanically seamed panel with nominally 2" tall rib and 18" (max) coverage.

#### Deck/Substrate:

15/32" (min) plywood or 3/4" (min) thick wood plank (*min S.G. of 0.42*).

#### Available Options:

22ga also available and acceptable (*22ga is thicker than 24ga min*).

12", 14", and 16" widths also available and acceptable (*12", 14", and 16" are less than 18" max*).

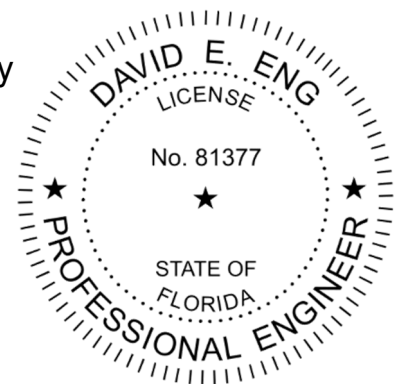

**Non-High Velocity Hurricane Zone (Non-HVHZ):**

This product *is approved for installation* **outside** the HVHZ (Miami-Dade & Broward counties). References to HVHZ sections of the FBC (e.g. Fire Barrier) generally do not apply when the product is installed outside of the HVHZ.

**High Velocity Hurricane Zone (HVHZ):**

This product *is approved for installation* **inside** the HVHZ (Miami-Dade & Broward counties), and other jurisdictions which require HVHZ or NOA approvals. Comply with HVHZ elements of the FBC where required.

**Underlayment:**

Comply with local building code or FBC 1507.1.1/1518.2 where required.

**Slope:**

Comply with local building code or FBC 1507.4.2/FBC 1515.2 where required.

OUTSIDE the HVHZ, FBC 1507.4.2 minimum slope is 1/4:12.

INSIDE the HVHZ, FBC 1515.2 minimum slope is 1:12 (this product has passed the requirements of ASTM E2140).

**Trim and Flashing Details:**

Outside the scope of this approval; refer to manufacturer's recommendations. Comply with RAS 133 where required.

**Re-Roofing:**

This panel may be installed over a single layer of existing shingles as permitted by local building code or FBC 1511/1521, provided the existing roof meets the conditions required by the applicable code. Size fasteners to fully penetrate ¼" (min) through substrate.

**Fire Barrier:**

Comply with FBC 1516.1 and 1516.2 where required. Optional where not required by code.

This product has been tested to the TAS 125 / UL 580 standard by Intertek Testing (TST-1527), report G3443.46-450-44 and to TAS 100 under report K9508.01-450-44. Tests are owned by Lara IP, and used with permission.

**Compliance Statement:**

**Design Process:**

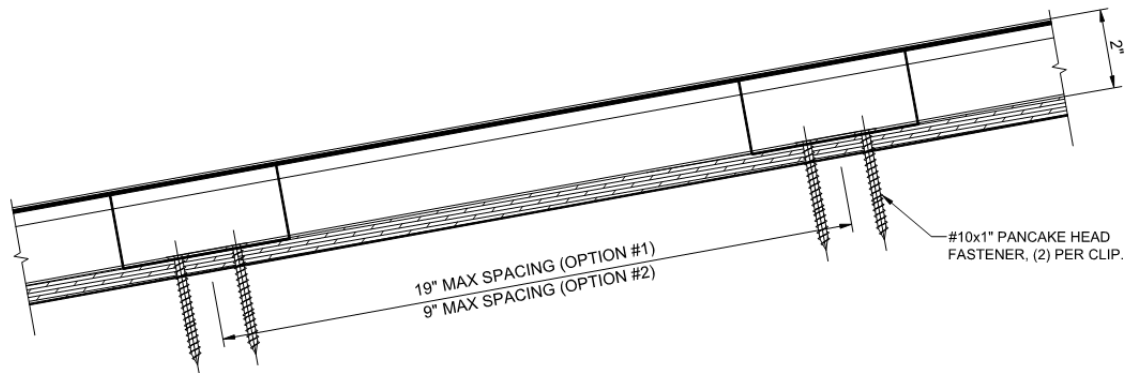

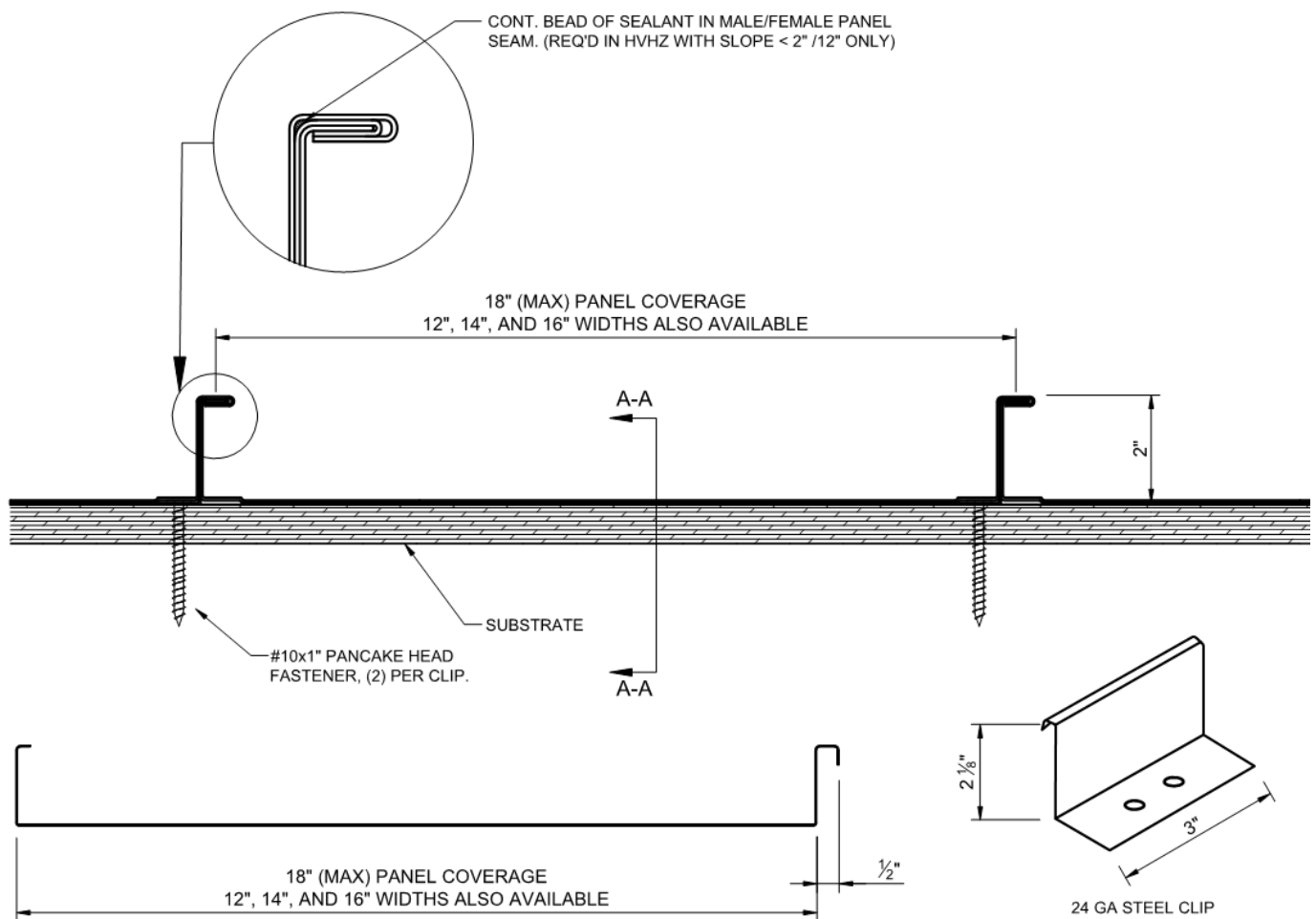
